For Managed Funds investors

A switch operates as the redemption of units in one managed fund and the investment of the proceeds in another fund. As such, it usually constitutes a realisation for capital gains tax purposes. Investors should consider this when making a decision to switch. You can switch all or part of your investment between the Australian Ethical Managed Funds.
